LAST MEETING - 28th January. - TRAVELLING POST OFFICES

The Meeting was to have been led by Jimmy Riddell. Unfortunately, he was taken ill at the last minute, and John Evans and Gerald Pratt very nobly took over. Jimmy had prepared some notes which John Evans was able to use in presenting Jimmy's collection of Marine Post Offices. Gerald Pratt used his own extensive knowledge of the Railway Travelling Post Offices to present the remainder of Jimmy's material. Our thanks are extended to all three; to Jimmy for the excellent material, and to John and Gerald for their last minute 'take over'.

REPORT OF MEETING

MARINE POST OFFICES
(From Jimmy Riddell's notes)

The First Period. 1863-1923.

Before N.Z. Mail Agents were allocated to ships, a NEW ZEALAND SHIP LETTER cancellation was used on mail from Auckland, from 1841 to 1845. This was a type of cancellation sent out to British territories abroad. It was intended for use on incoming mail, but in the case of New Zealand, it was used in error on outgoing mail. New Zealand stamps are also found cancelled by the obliterators used by the mail agents on the P and O ships from Sydney, on uncancelled mail. However, it was not until 1863 that the first N.Z. Marine P.O. cancellation was put into use on two ships plying between Port Chalmers and Melbourne, between 1863 and 1866. a duplex cancellation NZ Marine P.O. c.d.s., with an obliterator at the right with OTAGO across the centre. covers have been recorded. Recently it was found out that this cancellation with slightly smaller letters and no OTAGO obliterator, had been used on uncancelled mail on the Panama-New Zealand-Australia Line. I show one of two covers recorded showing this, with the uncancelled stamp cancelled with a Z in an oval of bars. In 1869 this Marine P.O. was closed, and the next recorded use of an NZ Marine P.O. was in February 1885 on the Sydney-Auckland-Apia-San Francisco run, although it is known that NZ Mail Agents were on board some ships before that date. I show examples of the four different types of the first cancellation used on the different ships, and the other different types of . cancellations., all of which are quite scarce.

In 1900 America took over the Hawaiian Islands, so the ships of the Union Steamship Co of NZ had to give up their part in this handling of mail, which they had been doing in conjunction with the Ocean Steamship Co of San Francisco. From 1900 to 1907 the Ocean Steamship Co carried on alone with three ships; the Sierra, Sonoma, and the Ventura. I show covers from all three, and their different cancellators.

Marine Post Offices (contd)

At the end of this period I show a very interesting and rare example of the cancellation used on the Wellington-Picton Ferry, of which only two or three fragments exist. I own this thanks to the generosity of Mr. Ken McNaught.

The Second Period. 1923 -1938.

There were two Lines. The first was the Canadian-Australian Line from Sydney to Auckland-Suva-Honolulu-to Vancouver. The second was The Union Royal Mail Line from Sydney to Wellington-Rutotonga-Papeete to San Francisco. So it was permissable to use, at one time or the other, the stamps of all these countries on letters posted on board. Each Line had its own cancellators, a ship's name c.d.s, and different Packet Boat, Loose Letter, and dumb cancellators. What has made this period so very complex from a cancellation point of view is that when a ship on one Line went off for a refit, a ship from the other Line replaced it temporarily....so... one finds letters posted on board one particular ship, with stamps cancelled with the cancellations of both Lines. This cannot be explained quickly and just has to be studied. I show covers from all the ships except one, and examples of all the cancellations except one.

At the end I show Pursers' cancellations, which are quoted in the NZ Handbook. Although they are not in reality N.Z. Marine P.O. cancellations, they were accepted, at times, in lieu of them.

The Marine P.O.s were closed down because of mail going by air.

RAILWAY T.P.O. CANCELLATIONS (From notes by Gerald Pratt)

It was a great privilege to see Jimmy Riddell's fine collection of RTPO cancellations about which he had whetted our interest in the articles he had written for KIWI in January and March 1966. This is a subject in which he is the leading expert, and which has never been adequately written up previously.

His collection provided a fine survey of these cancellations with maps to show the different routes. The various Index Letters and Numbers were also shown, together with examples of those wrongly applied. A few Flag Station covers were also shown.

Railway T.P.O. Cancellations (contd)

To those interested in starting to collect either Marine or Railway cancellations on cover, the ones to go after, and naturally the rarest, are those that have been posted on board and have the stamps actually cancelled with the Marine or Railway cancellation.

EDITOR'S NOTES.

My apologies if this issue seems rather overweighted with information on Travelling Post Offices. This has been done in an effort to combine as much detail as possible in the one issue, thus increasing its value to members as a complete reference copy in its own right. Even the page of cancellations which appeared in the January 1966 KIWI has been reproduced.

It is with deep regret that we have to announce the death of one of our members, Mr. Cyril Hilton of Leicester, and the resignation of Mr. L.B. Ward of Newcastle due to a serious illness.

The Letters of the Rev. Nihill. Members may have wondered what has happened to the extracts from the letters of the Rev. W. Nihill, who was a member of the Church Missionary Society in NZ from 1842 until his death in 1855. This series of extracts, edited by Jimmy Riddell, was started in the July 1965 KIWI, and ended rather abruptly in the middle of a letter, in the November 1965 KIWI. The remaining extracts have now come into my possession, and will be published as space permits. They contain some very interesting accounts of journeys across the North Island.

Postal History? Sgt. Grassie is the first member to notify us of the addition of a postal code to his address. These codes are being introduced in areas adopting automatic sorting of mail.

Page Numbering. Starting with Volume XVI, pages will in future be numbered consecutively throughout the complete volume. Thus you will notice that this issue, which is the second of the current volume, commences with page 19.

PROVINCE OF AUCKLAND DATESTAMPS.

The following table was sent to the Editor by Mr. R.M. Startup of N.Z, in July 1966. The table is a revised one of identifiable datestamp items, and has been brought up to date from several reports of holdings in N.Z, notably from Mr. Marcel Stanley, as well as the valuable work by John Evans in KIWI. It contains all the information up to and including that in the May 1966 issue, but John Evans points out that it may not include all the items listed by Mr. Joe Stonehouse in the July 1966 issue, although some of these items may have been previously notified to Mr. Startup.

Mr. Startup has divided the dates of the examples into Maori War Period 1864-6, and Relief Usage Period 1867-75. Members should re-read Mr. Startup's article in the May 1965 KIWI on this subject.

Editor's Note in connection with "Stamp Collection" in Noel Turner's Notes:-

ROSS $\frac{V}{4}$ CANCELLATION.

Extract from a letter from Ken McNaught to Mr. G.K. Molland in reply to an enquiry re Ross \underline{Y} marks. (See November 1966 KIWI).

"You will find that the normal practice in the early to middle period of N.Z. Postal History was to cancel the stamp with an obliterator (in this case $\frac{V}{L}$ in an eval of bars) and to indicate the name of the town of origin by applying a date-stamp alongside, or more commonly on the back of the envelope. As Ross is only a few miles from Hokitika, then the nearest port, (Greymouth, further north was probably just as important as Hokitika at that time), it is not surprising to find this cover backstamped at Hokitika a day later. In the case of offices not supplied with obliterators, the stamps were cancelled with the date-stamp. Those without date-stamps used manuscripts. A lot of people find Vol. 3 confusing, because Collins did not make it clear that mail was always date-stamped as well as receiving the obliterator markings. Several of us are working on the big job of finding out exactly what types of date-stamps were in use at all N.Z. offices during the period of use of these obliterators. As far as I am aware there are no official records of these date-stamps, so the story has to be laboriously built up from scraps of evidence in collections scattered throughout the world. In the case of Post Offices using obliterators, the date-stamp evidence has to be obtained from covers, though occasionally the stamps were cancelled by means of the date-stamps. In the case of Ross, I have 4 first side-faces (date range 1874-1878) cancelled in this way. I have examples of the V markings on first sidefaces P 12 (1874-8) through to second side-faces of at least 1887, possibly later.

There are a lot of unsolved postmark problems in N.Z. For example there is no record of the exact types of obliterators or date-stamps (if any) supplied to at least half the Offices shown on pages 45 and 46 of Vol. 3, and the illustrations 37, 38 and 39, are probably the only ches Collins could definitely allocate to the Auckland District from proving covers. Of the 245 places allotted numbers as shown on pages 45 and 46, I have only 67 different, and I have as good a lot as anyone.

Ross $\frac{V}{4}$ Cancellations (contd).

I am searching for proving covers, and in fact for clear examples of many of these whether on cover or not. I especially like the concentric circle obliterators of the type of 19, 20 on p. 44, 15 on P.49, etc. and also am keen on manuscript date-stamps. New examples are always turning up, but are hard to find on cover.

Gerald Pratt has a cover with Ross $\frac{V}{4}$ cancellation back-stamped Kumara 18.3.89, and Wellington 22.3.89.

THE 8d. PICTORIAL DEFINITIVES

I would ask those who are interested in this issue to look at the light grey area between the flowers and leaves.

In the early printings the whole grey background was mottled with no pattern showing.

I now have seen later printings from Plates 1111, and 1121, on which the light grey area is a fine mesh and quite distinct from the rest. At present it appears to change whilst 1/1 still shows the flaw and 1/9 stage 2, with the outline of the leaf added but the background still not coloured. Can anyone tie this down for those interested.

In the detail column, use of small letters indicates abbreviated version of full name.



- 15. In use from 1878 to 1882 as a sorting cancellation with type 1, and from 1882 till 1887 also to cancel adhesives on mail.
- a 33 mm cds with R.T.P.O. MAIN TRUNK round the top, 50 YEARS just below it, WELLINGTON N.Z. round the foot, with 15.2.1959 just above it, and a drawing of the T.P.O. railway coach across the centre. Used to commemorate the 50th anniversary of the Main Trunk R.T.P.O. Wellington cds on the 3 p.m. Auckland Wellington express.
- 82. A 34 mm eds with ROYAL TRAIN round the top, NEW ZEALAND round the foot and the date in one line in the centre. Dates from Dec. 19th to Jan. 4th and from Jan. 7th to Jan. 14th 1935 can be found. No 'philatelic' mail was permitted. Used on Official Mail during the visit of H.R.H. the Duke of Gloucester.
- 83. Machine cancellation similar to types 11 and 38 was used in August 1907 on the Christchurch Studholm Junction run to backstamp sorted mail consisting of six horizontal lines in the centre of the bottom three lines R.P.O. CHRISTCHURCH 07 AUG. In use for a few weeks only, because it was too difficult to carry the machine from one train to another.
- 83) Two other machine cancellators were installed for the backstamping of 84) mail on the Main Trunk line and the Auckland Thames line, and were in use from February 14th to October 1st 1909, when backstamping of mail was discontinued. The Auckland Thames cancellation was of five horizontal lines with AUCK-THAMES T.P.O. between the 2nd and 4th lines, and N.Z. above 1909, with date below AUCK-THAMES.
